## A Record-breaking Spring Celebration Event

On April 1st, Kennedy-Donovan Center held its fifth annual Spring Celebration. The event raised \$120,000, exceeding the goal by 18% and set a record for the most funds raised by the agency in a single event. All funds raised from the event are used to support KDC's mission.

This year's Spring Celebration was used as a platform for raising awareness to its first program: the Special Education School. Guest speaker Charleen Ferland shared her family's journey with the school and the important role KDC has played in providing services to her daughter for the past sixteen years. The crowd was moved to their feet by Charleen's touching account of life with Pitt Hopkins syndrome and the incredible impact KDC has had on her family. The event was attended by more than 210 guests and sponsored by corporations such as event sponsor Webster Bank, IneoQuest Technologies, and The TJX Companies. Auctioneer, John Terrio engaged the crowd with humor and passion as he raised over \$55,000 from the generous audience during the live auction and fundraising portion of the night.

Event co-hosts Anthony Karamas and Brad Pineault, who are KDC board members and long-time supporters of our mission, were able to tour the school and meet many of the students. They touched upon their visit to the school during the evening, and moved the crowd with the stories of the experience.

### Activities at Access Cape Cod

Kennedy-Donovan Center announced the launch of Access Cape Cod in 2015 as a three-year project to improve community accessibility for individuals with developmental disabilities on Cape Cod. With a \$280,000 grant from the Peter and Elizabeth C. Tower Foundation, this project's goal was to connect families and their communities for the enhancement of all Cape Cod residents with disabilities.

The project works to form social networks, develop meaningful social experiences, improve access to respite care, and expand community programs to both families and individuals 26 years old and younger who have developmental delays and disabilities on Cape Cod.

The intent and purpose of these planned events is to allow family networking and socialization groups for individuals with disabilities and their families. Events are free to KDC clients and a guest. Additional participants may be allowed at a reduced or covered cost depending on availability and staffing. While events are not open to the public, they are available to members of the Cape Cod community, including those who are clients of the Kennedy-Donovan Center, Access Cape Cod, have disabilities, and their families.

#### PIRATES COVE ADVENTURE GOLF

Our monthly mini-golf outing is a great way for individuals to interact with their peers and build mobility and concentration, while enjoying one of two Pirate-themed mini-golf courses. We've been able to provide access to people in wheelchairs as well.

# Leaving a Legacy

It is a good idea to review your estate plan regularly to ensure that it reflects changes you and your family may have experienced recently. Use this checklist to determine if you are prepared for anything unexpected that could affect the management or distribution of your assets after you are gone. Be sure to contact an attorney or financial planning professional when creating or updating your estate plan.

- Review your will and check for any changes that may need to be made because of a change in your life or tax laws.
- Be sure the executor you've named is still the appropriate person you want to manage your estate, minimize taxes, and distribute the designated portions of your estate to your beneficiaries.
- Update your designated beneficiaries to be sure you haven't named someone who is deceased or who no longer should be included.
- If you have designated a guardian for someone under your care, review your choice and make changes if necessary.
- If you haven't already done so, include a health care power-of-attorney in your estate for when you are unable to make decisions for yourself.
- Be sure your plan reflects your current assets and wishes for distribution.
- Consider adding your favorite charitable organizations to your estate plan as a means of minimizing taxes and leaving a legacy in support of your personal values. Including KDC is one way of assuring continued services on behalf of individuals with delays and disabilities, and their families.

### Generous Grants Awarded to KDC

Since our last newsletter, KDC received nine generous grants to help enhance programs and services. With the support of community foundations we are able to grow existing programs and build new services to reach more people in need.

Several program grants were received, including a \$400 grant from the Cape Cod Foundation, and a \$5,000 grant from the Edward Bangs Kelley and Elza Kelley Foundation to purchase SafetyNet bracelets for Cape Cod families with loved ones at risk of wandering; a \$10,695 grant from the Roy T. Morgan Foundation to purchase wireless internet for KDC's School in New Bedford; \$5,000 from United Way of Greater Attleboro/ Taunton to support our continued outreach

efforts for hard-to-reach families in Arabic and Spanish in the Attleboro area. We also received \$2,160 from CHNA 6 to provide a family support group for working parents of children with special needs.

KDC also received \$2,000 from the South Shore Playhouse Associates for social and recreational activities for our Day Habilitation Program; \$2,500 from Mansfield Bank for sensory and motor oral materials for our Attleboro Early Intervention Program; \$7,035 from the Balfour Foundation to furnish and purchase materials for our Attleboro Early Intervention's new classroom; and \$10,350 from Bristol County Savings Bank for a financial literacy program for our Foster Care participants.

#### **ACQUIRED BRAIN INJURY SERVICES**

24/7 support for those with acquired brain injuries in a staffed community residence.

#### **ADULT FAMILY CARE**

Finds homes for adults with medical needs with trained host families.

#### **APPLIED BEHAVIOR ANALYSIS**

Customized services for those with Autism Spectrum Disorder, and their families.

#### **DAY HABILITATION**

Provides adults with high needs a comprehensive program of services.

#### **EARLY INTERVENTION**

Home services for children birth to 36 mos. with, or at risk of, developmental delays.

#### **FAMILY SUPPORT & RESPITE SERVICES**

Supports individuals living with their families in receiving tailored services.

#### **FOSTER CARE SERVICES**

Works to prevent out-of-home placements; places children in qualified homes; and aids young adults transitioning to independence.

#### **HEALTHY FAMILIES**

Serves first-time parents age 21 or under until the child's third birthday.

#### **INDIVIDUAL SUPPORT**

Serves adults living on their own by providing drop-in support for daily living.

#### **SHARED LIVING**

Finds adults homes with host families trained to address their specific needs.

#### **SPECIAL EDUCATION SCHOOL**

For ages 3 to 22 with multiple disabilities.

#### SUPERVISED LIVING

24/7 support for adults living in groups of two to four in neighborhood homes.

#### SUPPORTED LIVING

Provides on-going supports to adults with disabilities living in their own homes.

#### TRANSITIONAL JOB SUPPORT

Assists adults in finding and maintaining meaningful paid employment.







# Luella's Leadership Circle

Luella Hennessey Donovan founded KDC in 1969 based on the principle that all individuals have the right to participate in their community. She was the private duty nurse for Rose and Joe Kennedy's youngest daughter Rosemary, who had a developmental disability. It was their wish that all children like Rosemary get to enjoy a typical family life and attend a local school. Luella founded the first educational and therapeutic, community-based program for children with special needs.

Today, KDC is dedicated to the support of those with developmental delays, disabilities or family challenges. Last year we established the Luella Leadership Circle in honor of Mrs. Donovan and her forewordthinking for people with disabilities.
